4. Public Broadband Act Passes House

Washington's long-held restriction on public utilities offering public broadband service directly to residents is one step closer to being overturned after the House voted 60-37 to pass the Public Broadband Act (HB 1336). Promoting rural broadband fits with a resolution passed by WACD members

- **The new Hub** is being well received. As a reminder, it is packed with information so you will need to drill down to the topics that are of greatest interest to you. The Hub is all business, all the time!
- **What has been recently posted?** The easiest way to see what has been getting posted to the Hub is to scroll partway down the home page to the [Recent Posts](#) block. Click on Recent Posts to be whisked to a page that lists in date order all published posts. You'll see the title of each item, and to the right, you'll see the posting date and the category or categories it was posted to. (Power tip: click the category name to view all posts made under that topic!)
- Scroll a bit farther down the page to find the **Districts in the News links**. Next to that block is the **Reading List** of news items that may range a little more widely than the content we publish on the Hub.
