5 Things to Know for April 15, 2021

1. WACD's budget priorities communicated

This week, WACD Executive Director Tom Salzer sent a letter to Washington State's budget reconciliation team members that outlined WACD's budget priorities in the reconciliation process. Read the letter at:

2. Congressional meetings this week

This week, an advocacy team from the Washington State Conservation Commission, Natural Resources Conservation Service, and WACD met with several congressional folks, including:

- Staff from Representative Marilyn Strickland's office
- Staff from Representative Kim Schrier's office
- Staff from Representative Derek Kilmer's office (with a brief visit with Rep. Kilmer between floor votes)
- Staff from Representative Dan Newhouse's office (with some phone time with Rep. Newhouse between floor votes)

All were open to our requests for support of conservation technical assistance (CTA) in the NRCS budget, support for CRP and SAFE acres, and support for increased access to broadband in rural areas. Several of the people we talked with in Washington D.C. gave us a distinct sense that a lot of pieces are moving on the USDA board right now. There seems to be a strong desire to see positive actions implemented in the near term for agriculture and for conservation.

3. Legislative flavor: The bills that died

If you Google NICRA you may run across the National Ice Cream Retailers Association. Ice cream is, unfortunately, not the topic of conversation at the next Community Call on April 30 at 9 am. NICRA stands for Negotiated Indirect Cost Rate Agreement.

The Washington State Conservation Commission's announcement says: "Conservation districts that have been successful in establishing a NICRA with a federal agency will share their experiences and lessons learned. A NICRA is an agreement governing the amount of indirect/overhead an

organization can claim on a grant from a federal agency."
