# 5 Things to Know for April 22, 2021

## 1. Budget expected Saturday from Legislature

The most current information we have is that the Legislature's budgets should be released to the public on Saturday. The House and Senate are expected to both vote on the final operating, capital, and transportation packages on Sunday, the last day of the scheduled 105-day session, and then adjourn before 11:59 on Sunday evening. Earlier talk of a possible special session seems to have dissipated. WACD does not expect a final opportunity to lobby on the budget. This means that any disappointments or additional needs while have to be addressed in the supplemental budget during the 2022 legislative session.

## 2. SAFE acres moved to CRP continuous signup

USDA Secretary Vilsack announced sweeping changes to CRP on April 21, 2021. Learn more at <u>https://hub.wadistricts.org/2021/04/usda-expands-crp-climate-change/</u>. There are still some wrinkles to be worked out regarding the SAFE acres cap but NACD is aware of this and is working on it.

### 3. Committees

- The **Finance Committee** has been meeting to review improvements to WACD's operations and as it prepares to receive the proposed budget for WACD. President Jeanette Dorner also appointed Barbara Bailey (Underwood Conservation District) to the Finance Committee. Welcome, Barbara! ### What is NICRA? Learn about it during the next Community Call

If you Google NICRA you may run across the National Ice Cream Retailers Association. Ice cream is, unfortunately, not the topic of conversation at the next **Community Call on April 30 at 9 am**. NICRA stands for Negotiated Indirect Cost Rate Agreement.

The Washington State Conservation Commission's announcement says: "Conservation districts that have been successful in establishing a NICRA with a federal agency will share their experiences and lessons learned. A NICRA is an agreement governing the amount of indirect/overhead an organization can claim on a grant from a federal agency."
