5 Things to Know for May 13, 2021

1. WACD board to hold Monday evening work session

The WACD Board of Directors meets monthly, alternating between work sessions on specific topics and regular board meetings to conduct the business of the Association. On Monday evening, May 17, at 6:00 pm, the Board will hold their May work session. The focus of that work session will be preparing the Board to take action in June on WACD's proposed budget. Translation: this is where we unveil the first pass at a draft budget to the Board so we expect a lot of back-and-forth as we work through the proposal. 2. WSCC to work on strategic plan and hold meeting

The Washington State Conservation Commission meets on Wednesday, May 19 to work on the Commission's strategic plan. On Thursday, May 20, the Commission will hold their regular meeting. Find more at <https://www.scc.wa.gov/commission-meetings>.

3. WACD annual meeting prep

WACD staff continues to work on options for WACD's annual meeting. We are considering a traditional in-person meeting, a wholly virtual meeting, and a hybrid that could consist of a virtual component and an in-person component. We also heard from districts that they would prefer a central location for the next meeting, so we are looking at venues in the Wenatchee-Ellensburg-Yakima area. We may have a proposal for the WACD Board to consider at their June meeting or this may take a bit longer. We will continue to report our progress on this topic, and

4. Getting ahead of the next legislative session

Even though the dust hasn't fully settled from the recently concluded legislative session, we know of issues that are likely to be front-and-center in the sphere of our member's interests. Like what, you ask? How about these as starters: net ecological gain and conservation district elections! We would like to eventually develop a "conservation caucus" consisting of supportive legislators and partners. Having a group of key folks who understand conservation districts would be very helpful as we face future challenges. When we help our supporters succeed, we succeed.

5. PMC update for May 13, 2021

Said Hermann Hesse: *"Some of us think holding on makes us strong; but sometimes it is letting go."*

Committee work continues to advance

The Finance Committee continues to work on WACD's budget and on refreshing our internal controls. The Joint Committee on Elections meets regularly as it works on possible changes to how Washington's conservation district supervisors are elected. The Committee on Diversity, Equity, and Inclusion is getting closer as we approach agreement on the final contract language with our consultant.
