The Committee on Diversity, Equity, and Inclusion (CDEI) met for the first time this week. Members spent their time getting to know each other more deeply and developing their working relationship with our consultants, Sarah Dryfoos and Dr. Cindy Caldwell.

The WACD Finance Committee work continues to move forward with the current focus being WACD's budget. We are also looking at some additional service providers. Once the budget is adopted, the Finance Committee will probably focus on WACD's investment strategy by crafting a proposed investment policy.

The Conservation Commission's and WACD's Joint Committee on Elections (JCE) also met this week. Featured was guest Sandra Hiatt who handles soil and water conservation district filings for the Oregon Department of Agriculture. Sandi gave an excellent overview of Oregon's system and responded to many detailed questions from Committee members. #### NRI webinar next week

At the May 20th Commission Meeting, the Conservation Commission adopted the new NRI (Natural Resource Investments) programmatic guidelines and landowner agreement. This was the result of the work of an NRI Committee of CD and SCC staff, who met over the last few months to draft the updated programmatic guidelines and an associated landowner agreement template. The changes include a new funding mechanism for conservation work, District Implemented Projects (DIP).
