### 5 Things to Know for June 3, 2021

#### 1. WADE conference starts in less than two weeks!

The annual training and networking conference presented by the Washington Association of District Employees starts in less than two weeks! [You can still register](#). If you're curious what is on the agenda, [the conference schedule has been published](#).

#### 2. Committees are active

[WACD's Finance Committee](#) continues to work on the Association's next budget as well as improvements to our internal controls.

The Joint Committee on Elections has held four meetings. Last week, the Committee heard from the elections officer for Oregon's soil and water conservation district elections. Next week, the Committee will hear from folks in Michigan whose election system is similar to ours. [Committee members are listed on the Hub](#) and near the bottom of the page is a link to "[JCE resources](#)" that requires a password to view; get the password from [Stephanie Crouch](#) or from [WACD staff](#). The JCE resources page shows previous agendas and also includes meeting notes from past meetings.

The Committee on Diversity, Equity, and Inclusion has met once. That session was focused on getting to know each other and finding some common threads that connect us. The steering committee will meet this week and we'll discuss setting the next meeting date. [Committee members are listed on the Hub](#).

#### 3. WACD Board to act on Association budget

On Monday, June 21st, WACD's Board of Directors will hold a regular business meeting. The June meeting will be focused primarily on the Association's budget for fiscal year 21-22 (July 1,

2021 through June 30, 2022). WACD has experienced some interesting changes in our usual conditions, including:

- the WACD annual conference was held virtually instead of in person;
- Plant Materials Center sales appear to have set a new record;
- the Executive Office moved to a new office location;
- returns on investments were higher than anticipated; and
- staff capacity is higher than it has been.

We expect some interesting discussions around the proposed budget. Please consider joining the meeting. Details will be posted on the Board Meetings page at <https://wadistricts.org/board-of-directors>.

#### 4. Time to work on the member services review

Now that the bulk of WACD's legislative work is concluded for this season, we can focus more attention on resolutions adopted at the 2020 WACD annual meeting. Find those resolutions at <https://hub.wadistricts.org/wacd/resolutions/>. WACD has been working on most of the resolutions but a few need more time/work, including:

- **Resolution 2020-01 Revolving Fund to Build CD Capacity** - This is in the hands of WACD's [Finance Committee](#).
- **Resolution 2020-09 WACD Member Services Review** - This work has not yet formally started but we have received interesting feedback from several district sources. We anticipate focusing effort on it in June and July.
