### 1. NACD summer meeting is this weekend

### 2. WACD Board of Directors meeting summary

During the WACD Board of Directors meeting on Monday evening, the Board welcomed Angela Reseland as the new WDFW Farm Bill Coordinator. The Board heard from several people from the Northeast Area Association of Conservation Districts about conditions and opportunities in their conservation districts. Our investment broker with Edward Jones briefed the Board on risk and WACD's investment performance over the past year. The Board received reports from partners and from the Tribal Relations Committee. Brief updates were presented about the Joint Committee on Elections and the Committee on Diversity, Equity, and Inclusion. In closing, the Board discussed options for holding their December meeting.
