5 Things to Know for August 12, 2021

1. Conservation Commission strategic plan comments due Monday

This coming Monday, August 16th is the deadline period to comment on the draft goals from the State Conservation Commission's 2022-2027 Strategic Plan. 2. CD elections listening session done, comments by August 18

The Joint Committee on Elections held a listening session yesterday with good participation and questions. The JCE is tasked with providing recommendations on conservation district election reforms to the Conservation Commission in September.

You can review the JCE's draft proposal and submit feedback. Comments are due by the close of business on August 18, 2021.

5. When talking with legislators, ask for what you need

We've had interesting conversations with several conservation district community members over the past few weeks about how much funding to seek from the Legislature. There is a difference between individual districts asking for financial support and asks from groups like

WACD and the Conservation Commission. Ours is a grassroots system, so your asks become powerful drivers in the overall system.

Don't sell yourself short when seeking funding. Just like selling a car, it usually works better to start high and compromise downward; doing this in reverse just doesn't work! If you ask your legislators for funds, please tell them what you really need.

While WACD may ultimately have to work toward a compromise package at lower funding levels, the process will likely work better if you don't lowball what you need. Asking for what you really need also demonstrates your belief in your district and your commitment to your community.

Conservation district email system: what to do?

Back in the long ago when I worked at the Conservation Commission, I set up a couple of Google Apps instances so conservation districts without email could get it at no cost. That system appears to have been running fairly smoothly for well over a decade, but what you don't see is what goes on behind the curtain. It is sometimes surprisingly difficult to manage the system. When I left the Commission in 2010, other Commission staff picked up this work and I applaud them for sticking with it for so long.

WACD is in discussion with Commission staff about how to move forward with managing the work of administering the Google mail system for conservation districts. The more I dig into this, the more complicated it becomes. I expect to survey conservation districts before the end of the calendar year on this topic so that your needs can guide us as we work to find more robust solutions.
