## 1. Area Association meeting dates now available

They are due back to WACD by October 29th.

#### 3. WACD annual conference plans

Over the last few months, WACD has carefully considered how to structure this year's Annual Conference. Last year was our first entirely virtual conference. We learned some lessons from that experience that will help us provide a better experience for you in 2021. While we were all looking forwarding to a traditional in-person conference this year, the spread of COVID variants and resulting restrictions have caused us to pull back from that approach. WACD has decided to proceed with a hybrid conference structure for 2021, with sessions being held virtually and the annual business meeting being held in person with a virtual option.

In the first few weeks of November will be virtual programming sessions with speakers, panels, and other presentations. After Thanksgiving, in the more traditional timeslot, will be an inperson business meeting (with a virtual participation option) on November 30 at the Hotel Murano in Tacoma.

To help cover costs, we will be asking you to help us look for conference sponsors. Look for

more information and a conference registration packet to come out by the end of September.

### Reflection: What is on the threat board?



### **District Directory survey**

A few weeks ago we asked for feedback on this question: should WACD stop publishing personal contact information in the District Directory? That survey closed with 27 responses. Nearly 60% of responses were YES.

Should WACD stop publishing personal contact information in the WACD District Directory? (We would make personal contact information available to authorized community members and through valid public records requests.)

The majority view gives us plenty to think about. There are public policy implications if we stop publishing contact information for individuals. On the other side, there are concerns about personal privacy, especially in this age of threats like phishing and identity theft. WACD will discuss this at an upcoming meeting. Thank you to those who participated in the survey and to those who reached out with more explanation about their concerns.
