### 1. September is resolution time

### 2. News of FarmPAI program announced

The Washington State Conservation Commission reported that the Washington State Housing Finance Commission (WSHFC) approved the creation of the Farmland Protection and Affordability Investment (abbreviated as FarmPAI, and pronounced as FARM PIE) program. With initial funding of \$7 million, FarmPAI will be a source of financing for the acquisition of land for affordable farmland access and long-term conservation. [Read more...](#)
