5 Things to Know for September 9, 2021

Dear weblinx,

While this was a short week for many because of the Labor Day holiday, it was just as busy as other weeks. WACD Olympia staff are gearing up for the WACD Board of Directors meeting and WACD Bow staff are closely monitoring plantings as they prepare for fall and winter. WACD Area Directors have talking points to aid them in working with our member conservation districts in September. If this sounds like it is "all hands on deck" time for WACD, that's because it certainly feels that way as we race toward October meetings of six area associations of conservation districts and WACD's conference sessions in November.

1. September is resolution time

Repeated from last week because this point is important: **September is resolution time!** September is the month when conservation district boards should be considering resolutions for consideration at area association meetings coming up in October. 2. Conservation Commission announces search for Executive Director

This week the Washington State Conservation Commission announced their recruitment for the Executive Director position. Dr. Carol Smith's last day of work will be October 15th. The Commission has appointed a Search Committee to help guide the recruitment process, including seeking an Interim Director while a permanent Executive Director is found.

The initial outreach for the job announcement included:

Reflection

With this being a short, busy week, I'm going to skip writing a full reflection.

The [Building Better](#) session held this week resonated with me deeply and it felt like it touched several of our conservation district managers, too. Our Building Better topic was: **Be a Bridge, not a Barrier: Managing the partnership with your Board and staff**. District managers, executives, and coordinators heard their peers express the need for trust, transparency, support, and leadership in their work with board supervisors and district employees. Unstated but evident was also a sense of needing to be committed to the success of the conservation district, not just as a conservation organization but also as a group of people that included board members and employees.

I don't remember having conversations like this 30 years ago. It seems we have had a seismic shift in the nature of the people who make districts function and that shift has been for the better. We have improved. We have become more capable, more professional, and also more caring about the most precious resource that affects our ability to succeed: people. Without you, our system breaks. I felt a very strong sense of community, caring, and support during the Building Better session.

Weekly thought

The book I'm reading now carries a quiet subtext throughout that is wholly about service to self and others. I'll write more about the powerful concept of [servant leadership](#) another time. For this week's thought, I'd like to share something by author Norman Fischer from his book titled [When You Greet Me I Bow](#).

"Knowing that it is impossible to do it perfectly, we can nevertheless do it as perfectly as possible, trusting our intention more than our information. Information in the modern age goes out of date almost as soon as it's gathered. Intention, on the other hand, can remain firm and help keep us on a wholesome course. Although it is shortsighted to trust to intention alone, intention's power to transform the world should never be underestimated."

In the context of my work with WACD, this quotation brings to mind the [ten guiding principles](#) in WACD's strategic plan. Those principles are guideposts that help us remember what is most important as we go about our work in service to our members.
