## 5 Things to Know for October 14, 2021

For the past several weeks we've been ramping up work for [annual area association meetings](#). The moment arrived this week with the annual meetings of the Southwest Area Association of Conservation Districts and the Northwest Area Association of Conservation Districts. While we wish we could be meeting in person, it was still very pleasant and informative to meet virtually with so many conservation district supervisors, associate supervisors, staff, and partners.

Next week the North Central and the Northeast area associations will meet. The week after that, the South Central and Southeast area associations will take us to the finish line on area association annual meetings this year.

### 1. Five resolutions adopted at SW, NW Area Association meetings

On Wednesday, the Southwest Area Association of Conservation Districts adopted two resolutions. On Thursday, the Northwest Area Association of Conservation Districts adopted three resolutions, including one that was adopted yesterday by the Southwest Area:

- NWAA 2021-01 WACD Sustainable Funding Committee (as adopted)
- NWAA 2021-02 Establish HAB Workgroup (as adopted)
- NWAA 2021-03 NRC Reimbursable Rate for Riparian Practices (as adopted)
- SWAA 2021-01 Sustainable Funding Committee (as adopted)
- SWAA 2021-02 Workplace Policy Improvements (as adopted)
