# Call to Action: SHB 1652

House Bill 1652 was amended in committee with the addition of some disclosure requirements for elected and appointed supervisors. The resulting legislation is Substitute House Bill 1652, abbreviated as SHB 1652.

As you recall, there was competing legislation with HB 1910, a bill requiring all conservation district elections to be conducted in November general elections. That legislation did not advance. The prime sponsor of that bill, Representative Gregerson, has filed an amendment for SHB 1652 which would strike everything currently in SHB 1652 and turn it into her legislation in HB 1910. This "striking amendment" would turn SHB 1652 on its head by requiring that all CD elections be conducted under Title 29A election laws.

Such an amendment discounts the important advances achieved by the Joint Committee on Elections and our entire community on the subject of conservation district elections. It takes a core principle that drives our conservation delivery system — locally-led conservation and the ability of communities to choose — and replaces it with a top-down, one-size-fits-all system that will irreparably harm conservation districts.

Today, we issue a call to action, **asking every member to contact their legislators in support of SHB 1652 without the Gregerson striker**. We need legislators to understand that forcing elections to be held on the November ballot will bankrupt conservation districts, reduce service, and result in the loss of many experienced board supervisors.

Amending SHB 1652 to be more like HB 1910 is a conservation district killer. We need your help now to stop this from happening. **Please contact your legislators immediately in support of SHB 1652 without** <u>Representative Gregerson's striker</u>.

### Dear weblinx,

As the impending spring season stirs thoughts of getting more work done outside, the Legislature has reached the halfway point in this short session.

The policy cutoff date for bills was last week and the fiscal cutoff was the beginning of this week. Bills that did not make it past those hurdles are effectively out of play for this session. As noted last week, there is an exception: if a bill is necessary to implement the state budget, then it can still be pushed through at a later date.

While WACD staff continue to monitor the progress of several bills, much more of our attention is now focusing on the supplemental budget.

#### 1. Legislation: what is still alive after cutoff?

During the Legislative session, proposals must reach specific checkmarks at certain times in order to continue along the process to becoming a law. We have now hurdled two benchmarks. Bills with policy or fiscal implications are out of committee and will be considered by the full House or Senate. #### 2. We want your comments on the CD elections bill

WACD is seeking input from its member districts on the committee amendments made to SHB 1652. This is WACD's priority legislation for this session, with the goal of the Legislature adopting the recommendations from the Joint Committee on Elections. We've heard from a few districts that they still support the bill with the committee's amendments, but want to make sure we're reflecting the will of our entire community. #### 3. Call for Harmful Algae Bloom Task Force Volunteers

WACD is responding to a resolution adopted at the 2021 Annual Business Meeting to form a temporary group dedicated to assessing the emerging issue of harmful algae blooms. ### From your Executive Director

### Planting seeds and killing weeds

We all know that to grow many desirable crops, we have to plant seeds. We prep the field, maybe check the soil to see what amendments are needed, then carefully time the planting. As plants grow, we also know we need to reduce competition for light, water, and nutrients by suppressing weeds.

Those same concepts also work when it comes to legislation. People in our community did good work planting seeds through their work on the Joint Committee on Elections. Subsequent work with legislators resulted in House Bill 1652 that supports the Committee's recommendations.

We now hear that some weed seeds are going to be planted into the elections bill. I'm talking about a striker filed by Representative Gregerson that, more or less, converts SHB 1652 into HB 1910, a bill she sponsored that didn't make it out of committee.

Gregerson's amendment removes choice by conservation districts. It would mandate that all conservation district supervisors be elected under Title 29A general election processes. And it leaves conservation districts footing the bill. In a bid to create more inclusion and equity, the amendment would be incredibly inequitable to the majority of our conservation districts. They would not be able to pay for their elections without harming their ability to serve their community. This amendment effectively guts the good work of our community, flips the entire intent of HB 1652, and harms conservation districts.

This is one of those rare "all call" moments when we need every person in our community to contact their legislators to help stomp down some weeds. We believe in the locally-led process. You believe it, too. Now is the time to take action on the basis of that belief by contacting your legislators today and expressing your strong support for HB 1652 because it respects choice in each community served by conservation districts. WACD supports HB 1652 without Representative Gregerson's striker.
