Five days until our members and partners come together in Wenatchee for a few days of learning and collaborating. Monday and Tuesday represent the learning and social prelude to the Association's annual business meeting. The decisions reached on conservation district resolutions at the business meeting establish priorities for WACD. Voters decide how WACD should invest its time and talent on behalf of conservation districts.

It is also fall, a time when snow falls in our mountain passes. While snowfall is something that road crews in the passes and in eastern Washington are familiar with, you may be uncomfortable driving in snowy conditions. We recommend that you review pass reports, start your journey early, bring some extra water, food, and blankets, and carry tire chains. Meanwhile, road crews will be working to provide the safest possible driving conditions for you. Take your time, be careful, and enjoy the incredible scenery along the way!

1 – WACD annual conference update (November 28 & 29)

We look forward to seeing you on Monday, Tuesday, and Wednesday!

2 – Legislative priorities (preliminary)

At the <u>November 21 WACD Board of Directors meeting</u>, the Board voted to adopt a set of <u>preliminary legislative priorities</u> to guide WACD's work in the 2023 session based on WACD's current policy positions. The priorities suggested were modified at the meeting to include supporting Salmon Recovery Funding Board grants that conservation districts receive. These priorities are subject to change after resolutions are presented and decided by WACD voters next Wednesday. Priority topics are listed below and details are available in the Board meeting folder linked above. Feedback on these priorities is welcome, whether by districts or individuals; please <u>contact Ryan Baye</u>.

3 - Legislative Day is set for February 8

WACD will hold a Legislative Day on February 8 in Olympia to help conservation districts connect with legislators. If your district is interested in coming to Olympia and require assistance scheduling appointments with legislators, <u>Register online</u> by January 6 or <u>contact</u> <u>Ryan Baye</u>. Expect more information during December after the Annual Conference.

4 - Bylaws changes proposed
