

WACD Legislative Update

January 23, 2023

This is WACD's second week of subscription-only legislative updates for 2023. These weekly updates contains timely information about legislative activities affecting conservation districts in Washington State.

1. Testimony on HB 1215

Last Wednesday, the House Agriculture and Natural Resources Committee held a public hearing on HB 1215 (Concerning the protection and restoration of riparian areas). Four individuals from our community testified on the bill, and we wanted you to bes

2. WACD Legislative Day

3. Legislative Overview

4. CD Elections

Though a bill containing the recommendations of the Joint Committee on Elections is not yet in front of the legislature, we are still working to achieve the outcome laid out in Resolution 2021-17. After meeting with the Chair of the House Committee on State Government & Tribal Relations in the first week of session on this topic, we are now aware of at least one proposal being written that contains neither the JCE's recommendations nor a repeat of last year's HB 1910 that would have placed all CDs on the general election ballot.

We expect to see this proposal introduced sometime in the next two weeks, we will make sure the entire membership is aware of the bill when we know more.

5. Hearings This Week

<u>WACD's Legislative Watch List</u> includes which of the bills we're following are scheduled for a public hearing. This week, three bills are worth highlighting:

- HB 1381 (Concerning salmon-safe communities) is being heard in the House Environment and Energy Committee at 1:30 PM on Monday, January 23rd.
- SB 5353 (Concerning the voluntary stewardship program) is being heard in the Senate Ag & Water Committee at 1:30 PM on Thursday, January 26th.
- SB 5390 (Establishing a programmatic safe harbor agreement on forestlands) is also being heard in the Senate Ag & Water Committee at 1:30 PM on Thursday, January 26th.
