## Five Things to Know for September 21, 2023

### 1 – WFFA seeks conservation district support for carbon project

The Washington Farm Forestry Association has produced a one-pager on an Inflation Reduction Act grant proposal for which they seek conservation district support. It explains where WFFA wants to go with this IRA grant that is aimed at connecting small forest landowners to markets and resources that can help them improve their forest management, reduce the potential for carbon release, and help establish viable biochar markets in Washington state. ### 2 – CD elections study delayed

WACD has verified that the conservation district elections study authorized in the 2023 session by the Washington State Legislature has been delayed. The Washington State Institute for Public Policy was supposed to issue a preliminary report on December 1st of this year with a final report June 30 of 2024, but cited capacity issues when their Board of Directors pushed back the preliminary report to December of 2024 with a final report in 2025.



## Executive Corner

### Immersed in change

I'm sitting in the Washington State Conservation Commission in Clarkston meeting listening to Commissioners grapple with the immense number of change occurring in our systems and in the external conditions affecting us. I could wax poetic about how hard change is on each of us and on all of us, but you already know this because you are dealing with it, too.

I've never seen this much change hitting us in such a compressed window of time. It's hard. It's difficult. If you're struggling with it, rest assured you are not alone. We are adrift in shifting expectations and inundated with change.

To echo this theme, a few of us on the tour of Asotin County CD projects on Wednesday came up with a short slogan appropriate for T-shirts, hats, and bumper stickers: "shift happens". I think this humorous slogan may reflect how many of our community members are feeling. Shift happens.

### This season of change

Right now, our community is dealing with the loss of a long-time Commission employee, the search for a new Executive Director for the Commission, Conservation Reserve Enhancement Program contracts, and many more topics.

At the same time, record levels of funding are being made available at both the state and federal levels. The magnitude of these funds present a huge conundrum for conservation districts because if they apply for and win a big grant, how do they immediately expand their

capacity to get the work done?

Funding for training and building capacity in conservation districts seems to be lagging far behind the need expressed by districts. This has quite a few district folks very stressed because, like all of us, they want to do the best job possible and they want to support their communities and improve natural resources.

Stepping back from these stressful topics, I'd like to observe that conservation district people do this work because they are driven to do it. An individual's conservation work is powered by their heart and implemented through strong minds and hands. We certainly aren't in it for the money. In transitional moments like these, I fall back on the foundations and remind myself what compelled me to conservation in the first place. That helps me find my center so I can charge once more into the breach.

And it also helps to know help is coming, WACD is happy to see that the Conservation Commission included \$10 million for Conservation Technical Assistance support in their budget package for the 2024 legislative session. Roylene Comes at Night discussed at the Asotin County CD Tour dinner how many new staff NRCS is bringing into the state. There is hope that change will continue, this time to make it just a little bit easier for conservation districts to achieve their purpose. That, in a phrase, shift happens.
