# 5 - Forestry Funding Alert

The application period is open for the USDA Forest Service Inflation Reduction Act Forest Landowner Support Grant. This grant's objectives include:

• Support the participation of underserved forest landowners in emerging private markets for climate mitigation or forest resilience.


• Support the participation of forest landowners who own less than 2,500 acres of forest land in emerging private markets for climate mitigation or forest resilience.

Proposal budgets greater than or equal to \$2 million and less than \$25 million are due by October 21, 2023, 60 days following publication. There is a "Track B" option where proposal budgets less than \$2 million will be considered for funding on a quarterly basis until August 21, 2024.

### **Executive Corner**

### The value of interacting with peers, both near and far

This afternoon, I returned from a board meeting of the <u>Association of Conservation Executive</u> <u>Directors</u> held in Franklin, Tennessee, just outside of Nashville. I sit on that board as the Pacific Region Representative.

While I wish I could say I enjoyed the unique sights and sounds of Nashville, the truth is we were so busy that I never made it downtown. We spent a day in a conference room without windows and spent the next day touring various operations deemed important by our great host, the <u>Tennessee Association of Conservation Districts</u>.

Trips like these always feel expensive. That begs the question: what value do we get from meetings like this?

Speaking of this meeting in particular, I came away with several ideas and observations, like:

- How lucky we are to have 45 effective conservation districts!
- Appreciation for the level of engagement our conservation district board supervisors and managers have in the affairs of their statewide association of conservation districts.
- Ideas for better area meetings, including holding more than one meeting a year.
- Ideas for better WACD annual meetings!
- Conservation district fundraising ideas from the elevator speeches each of us gave.
- I also learned that NACD really does need more breakout session proposals (see item 2 above). This is a great opportunity to showcase something special about your district.

Mostly, though, my sense of gratitude for our conservation district community was renewed. As I listened to the challenges many other state associations are experiencing, I felt very lucky to be associated with our tremendously strong conservation delivery system and the people who make it work so well.

There were other realizations, too, that might feel more troublesome. The conservation district members of many state associations are struggling with how quickly diversity, equity, and inclusion have surfaced in their grants and communities. Just like many of us, they don't feel well-prepared for those conversations. Fortunately, in Washington State, we are working on this with those districts that want this kind of learning. There's a great example of DEI work in Oklahoma that is worth taking a look at. Their program is called <a href="#care-conservation">CARE: Conservation & Agriculture Reach Everyone</a>.

Some state associations have trouble getting their association board to engage and attend meetings. We haven't had too much trouble with this. The highlight for one state association board seems to be going to the NACD Annual Meeting. That association sends all of its board members to NACD every year.

We had conversations about association dues. I learned that state association dues are all over the place. Some states use a formula like we used to have. I was surprised to discover that the majority of states represented at the board meeting have gone to a system like ours, where the dues are the same for every member district. And I was pleased to learn that our dues are not

the highest in the nation; another state association levies dues of more than \$5,000 per district!

Most of the state representatives at the meeting were very interested in the WACD Plant Material Center. Some representatives even suggested that Washington should host an ACED board meeting at the PMC.

What am I getting at in this Executive Corner piece? Interacting with your peers helps put what you are doing into perspective. Whether it is district managers/executives interacting, board supervisors getting together, the WACD Annual Conference, the NACD Pacific Region Meeting, or the NACD Annual Meeting, sharing your issues and ideas with peers generates new ways of thinking about old problems and provides context for the issues you face in your home district. What is the value of gaining more appreciation for the great things you do and discovering new ideas to bring home? I don't think we can measure this in dollars.

That's deep enough. I got up at 1:00 am Pacific Time to catch my first flight of the day and it's now 4:00 pm. It's been a long, tiring day, too long to keep harping on the many things I learned on this trip. I hope you enjoy the photo stack and gain some appreciation for your own great work in your home district, and the good work that your own state association is doing for and with you.
