## Executive Corner

### Rocketing toward the annual conference

After many months of preparation, we suddenly find ourselves with just a week-and-a-half to go before we are in Wenatchee. While the conference hasn't snuck up on us, we are nevertheless scrambling to make sure we've tied a ribbon around the entire conference package for those who join us in Wenatchee. Some of us might be experiencing a little bit of sleep deprivation but I'm sure we'll be recovered by Monday, November 27!

### 81 years

This will be WACD's 81st year of service and representation, an amazing accomplishment. Over the eight decades your Association has existed, many things have changed. The capacity of conservation districts to help put conservation on the land began to change dramatically after the Clean Water Act was passed in 1974. The clean water funding that came along after that flowed to states and some made it to conservation districts. Staffing at conservation districts changed, with many growing from employing a part-time secretary to having a full-time technician or manager on staff.

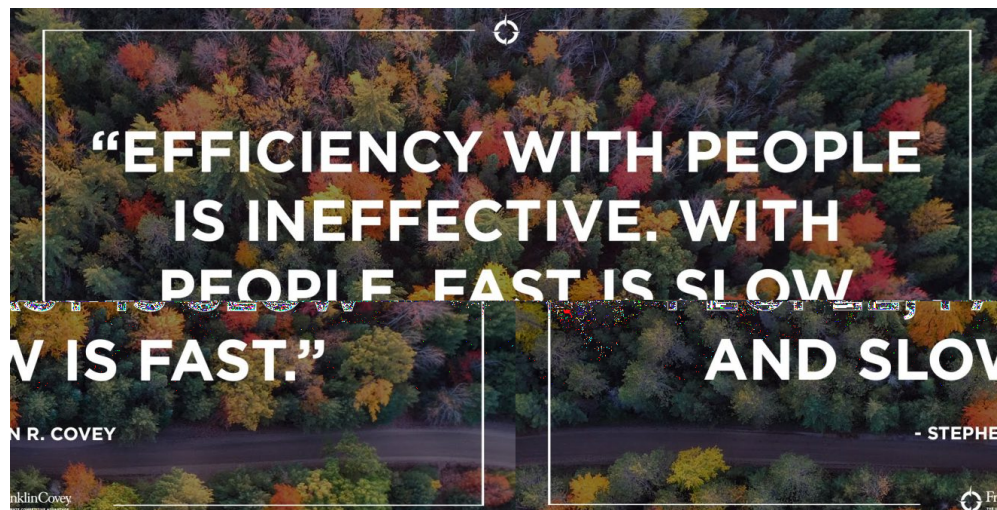
Before 1974, much of the work was done by conservation district board members. With growth after the Clean Water Act, work shifted over many years from board members to district staff. The job of being a board member became more difficult as capacity and complexity increased, resulting in increased reliance on professional, skilled employees.

Today, people in conservation districts find themselves pushed and pulled in many directions at once. Conservation district capacity is at an all-time high. With the funding levels we are seeing from the state and other sources, it is clear that our capacity is going to make another evolutionary jump.

Can districts rise to this challenge? They always have, and I believe they always will because our people are driven by strong belief and passion. Serving on a board or serving as a district professional both reflect who these folks are and the conditions they want to have in their communities. Conservation districts continue to support local needs and continue to get important conservation on the ground. Can they rise? Yes!
