## WACD Week 9 Legislative Update

**March 05, 2024**

We are in the waning days of the legislative session, with Thursday March 7th only three days away. In this home stretch, the legislature is reconciling the differences between the House and Senate versions of the Operating, Capital, and Transportation supplemental budgets, as well as the approximately 160 other bills needing to iron out their differences before Sine Die. It is not always an easy process, bills die every year despite being passed by both chambers because the sides couldn't come together.

### 1. Remaining Reconciliation Priorities

As shared in our 5 Things newsletter last week, WACD contacted the [operating budget negotiating team](#) with WACD's perspective on the need for Conservation Technical Assistance Funding and funding new staff positions at the Commission. That group of six legislators (Senators Robinson, Nguyen, and Wilson alongside Reps. Ormsby, Gregerson, and Corry) are finding compromises on differences between the two budgets.

As we shared, WACD prefers the House operating version when it comes to funding conservation districts. There is \$3.5 million for CTA in the House operating budget proposal with no funding in the Senate version. Additionally, the House funded the Commission's request for six new FTE's while the Senate only funded two positions. As per the membership's vote on Resolution 2023-17 in Wenatchee to support the Commission's 2024 budget request, WACD will be communicating with the negotiators our memberships support for the \$3.5 million and support for the Commission's operational funding. Feel free to reach out to your own legislators as well.

## 2. Legislative General Review

As part of her services, WACD's Lobbyist Brynn Brady writes a general review of major legislative topics covering the previous week. We share it with our membership so you are informed of non-district topics that are being discussed in Olympia. This week's review discusses the three initiatives heard by joint legislative committees last week, legislative retirement announcements, and criminal justice legislation.

### 3. Legislative Cut-Off

Friday March 1st was the final legislative cut-off before the session is scheduled to end on the 7th, where all bills must be approved (in some version) by both chambers. The final few days will be devoted to the reconciliation process, to ensure only one version of a bill is sent to the Governor's Desk.
