## 4. Comment Now on the Proposed Listing of Two Species

The U.S. Fish and Wildlife Service is currently accepting comments on the proposed listing of two species under the Endangered Species Act.

(proposed Endangered) –

The Service particularly seek comments concerning threats and conservation actions affecting the species; its biology, range, and current status; and reasons as to whether or not designation of critical habitat for the species may be prudent. The proposed listing rule, supporting materials, and information on how to submit comments can be found on [regulations.gov](https://www.regulations.gov) by searching for docket number FWS-R7-ES-2024-0117.

(proposed Threatened) –

The Service particularly seek comments concerning threats and conservation actions affecting the species, and whether they should include an exception for the use of pesticides and, if so, what measures are reasonable, feasible, and adequate to reduce or offset pesticide exposure for monarchs.
