## Five Things To Know

### 1. Capital Budget Update

On Monday, March 31, the House and Senate released their proposed Capital Budgets. Those budgets can be found [here](#). Both the House and Senate versions mostly retained, or slightly increased, Capital funding levels for the State Conservation Commission's programs. It is still early in the process. Budgets will need to be approved by the Governor who, so far, has been very critical of proposed tax increases necessary to fund House and Senate budget proposals. One surprise in the Senate Capital budget was a whopping 25 million dollar increase in Riparian Grant Program funding, bringing their total proposed allocation to 50 million dollars. We believe this could be an inadvertent error that legislators may correct as budget negotiations move forward.

Across agencies, we have seen proposed increases in riparian grant funding levels and an across the board lack of investment in forest health and wildfire resiliency. The House and Senate will now negotiate a compromised version of their budgets.

WACD has already started developing language for districts to use around reconciling the difference in the Senate and House Operating budgets. We will send that out shortly. We are also beginning to develop a campaign to seek reinstatement of forest health funding in the supplemental budget as we do not expect to see major increases in that funding category this session.



### 2. Rates & Charges Bill Update

On March 26, the Washington State Senate approved an amended version of [SHB 1488](#). The amendment places a \$25-per-parcel cap on rates-and-charges fees. A mechanism to adjust the cap in response to inflation was also added. The adjustment is intended to help rates-and-charges fees keep pace with inflation, i.e., to help communities enjoy a continuous level of service from the conservation district that serves them.

Since the bill language differs in the House and Senate versions, the bill will next go to a House-Senate conference where final language will be negotiated. Once there is concurrence on the final language, the bill will be sent to the Governor for final approval.

WACD would like to thank all of the Districts who assisted with garnering support for the bill and the legislators who sponsored and voted for it. WACD's lobbyist Brynn Brady did a phenomenal job of shepherding the bill through the legislative process. **Thank you!**

## Executive Corner

With those takeaways out of the way, here are the Executive Corner thoughts for this issue!

Most folks have little idea how much work goes on behind the scenes during Legislative session. The most obvious group of people — legislators — are up early and staying late to work on needs brought forward by the communities they serve. Weekends? That's work time. Holidays? More work time. It is an exhausting grind for legislators and the legislative assistants who support them. Most legislators aren't based in or near Olympia so they are holed up in housing situations that are not always very restful. When you next talk with your legislators, please thank them for their hard work. They don't hear thank you enough.

WACD is grateful to the many conservation districts that have created and nurtured relationships with their elected officials. It makes a huge difference! You may think that your casual conversation with a legislator is of little importance, but in reality, they remember and appreciate you. You are a connection to home and a trusted voice they can count on. Often, we go into a legislator's office and start to explain what conservation districts are, only to be interrupted with a smile and a comment like: *I know my conservation district very well and it does great work.* Legislators knowing and appreciating their local conservation district has value beyond any price.

Building these relationships takes work. It is often easier for a rural district to do so as it may only have a couple of representatives and a senator to keep in touch with. In rural districts, you may see your elected official working in the yard or at the grocery store. It's a neighbor-to-neighbor kind of relationship that can be very powerful.

However, imagine what some of our more populated districts have to deal with! In heavily populated conservation districts, it can be a heavy lift to stay in touch with all of their elected officials. Is it worth it? Without a doubt, yes! We see it each year as we make the rounds. We hear it from Conservation Commission staff and from WACD's lobbyist. The more legislators who know they have a local conservation district, who have heard what it does, and who understand the value districts provide in their communities, the better not only for your district but for all districts. The more who can also connect a district's work with a face and a name from home are often the most powerful allies for local conservation.

Of course, let's not forget our Conservation Commission board members and staff, as well as WACD board members. Each person brings connections and perspectives that expand the

reach of the conservation district movement. It really does take a village.

We don't always agree on everything, nor do we need to. What makes our system work is we are willing to debate the pros and cons of an idea and then follow the majority decision reached by conservation district members...even when we don't completely agree with the decision. There is great strength created by arguing for your preferred position and accepting the choices made by the majority. When WACD is able to communicate to legislators that we are speaking for all 45 conservation districts across the State of Washington, that is meaningful. It carries some weight. Thank you for participating in discussion and decision making, and thank you for supporting the decisions reached by WACD members.
