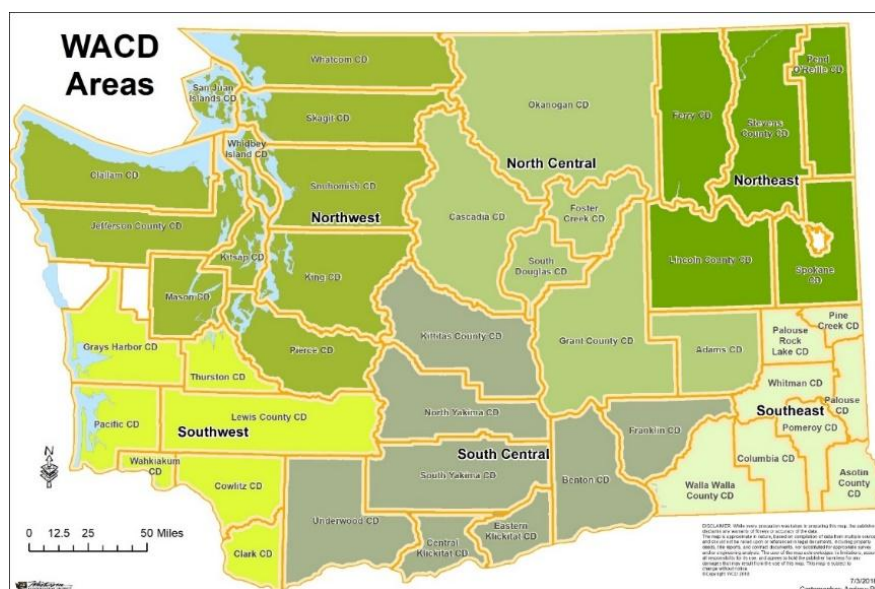

The mission of the WACD Plant Materials Center is to grow high quality conservation plants, materials, and service for the benefit of natural resources and conservation projects.

WACD began operating the Plant Materials Center in 1993. The 60-acre conservation-grade nursery, located in Skagit County, produces over 1.5 million bareroot plants and live stakes each year with over 80 different species. The bareroot plants are propagated from source-identified seed collections from reputable sources throughout the Pacific Northwest. Single and multi-year growing contracts are also available.

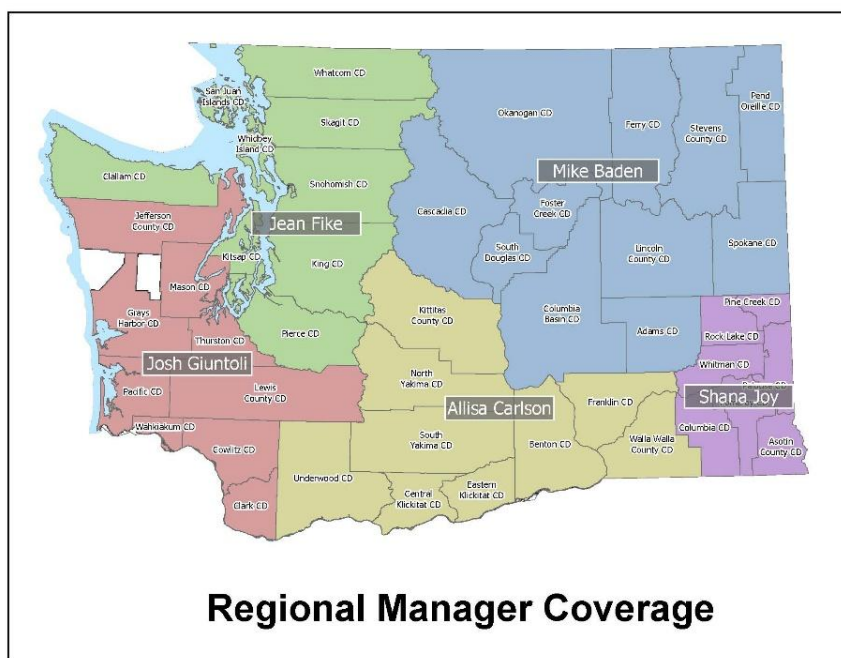

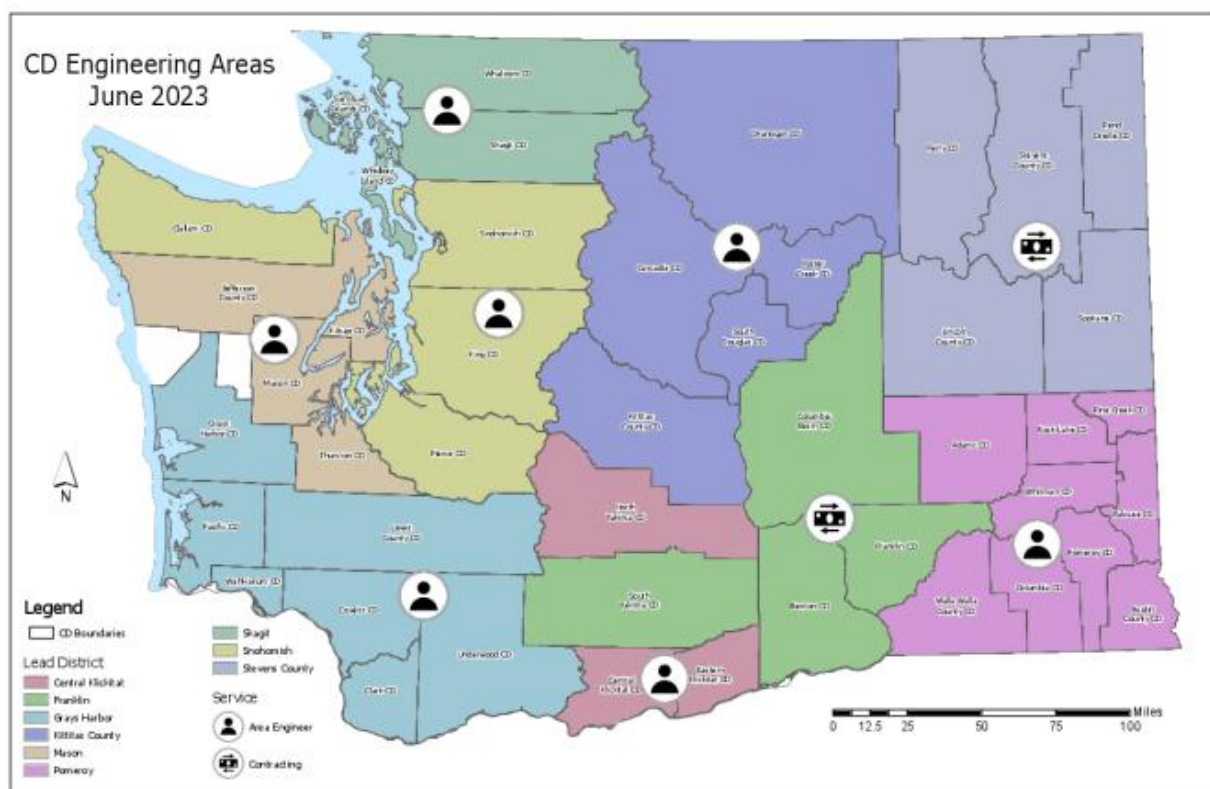
