Job title: Salmon Reintroduction Grant and Project Manager

**Location:** Spokane, Washington; hybrid work option

**Position type:** Full-time

# Job summary:

The Upper Columbia United Tribes (UCUT) are in the process of reintroducing salmon to areas located upstream of Chief Joseph, Grand Coulee, and the Spokane River dams. The Coeur d'Alene Tribe (CDAT), Confederated Tribes of the Colville Reservation (CTCR), Spokane Tribe of Indians (STI), and their consortium UCUT, are the leaders in returning anadromous fish to historically occupied habitats above these barriers. Collectively, they and their partners are implementing a 21-year plan to design, install, and test fish passage facilities and salmon reintroduction strategies. The UCUT organization and its member tribes have been working together to garner policy support for the reintroduction effort, secure funding needed for salmon reintroduction activities, conduct research, and perform cultural and educational releases of salmon to the tribes' waters.

The Salmon Reintroduction Grant and Project Manager will be responsible for administrative and accounting support to both the consortium and the member tribes. This will be accomplished through four main tasks: 1) administratively manage salmon reintroduction projects that involve the UCUT organization and the member tribes; 2) pursue funding opportunities; 3) manage salmon reintroduction budgets for the UCUT organization; and 4) coordinate salmon reintroduction communications amongst the UCUT organization, the member tribes, and regional partners.

#### **Essential functions:**

- 1) Provide comprehensive project management to UCUT organization and its member tribes to successfully plan for and execute activities to support salmon reintroduction in the blocked upper Columbia.
- 2) Manage multiple projects at once, tracking progress, meeting milestones, adapting approaches in real time, and providing administrative reports.
- 3) Identify opportunities to seek outside funding sources to enhance the capability and capacity of the UCUT organization and its member tribes related to salmon reintroduction.
- 4) Keep accounting and budgeting records of activities for salmon reintroduction, reporting on individual projects and the overall effort.
- 5) Assist with the development and submission of project proposals to several types of funding opportunities (e.g., competitive grants, congressional requests, etc.).

- 6) Draft contracts with potential funding organizations as well as subcontractors.
- 7) Manage sub-contracts.
- 8) Follow internal procurement policies to make necessary purchases.
- 9) Coordinate and facilitate internal and partner meetings related to salmon reintroduction.
- 10) Establish and maintain relationships with the member tribes, regional partners, and subcontractors.
- 11) Contribute to the review of technical reports.
- 12) Occasionally assist in salmon-related fieldwork with the member tribes.
- 13) Attend conferences and training as required to maintain proficiency.
- 14) Perform other related duties as assigned.

### **Competencies:**

- Proficient in project management tools and processes.
- Demonstrated ability and experience in grant writing.
- Demonstrated ability and experience in budget management.
- Strong organizational, interpersonal, and communication skills with the ability to facilitate small group meetings and work sessions and collaborate with the member tribes and regional partners.
- Demonstrated ability to set priorities and manage numerous deadlines and deliverables.
- Team worker and leader.
- Willing and able to travel occasionally throughout the Pacific Northwest and British Columbia.

#### **Minimum Qualifications:**

- Bachelor's Degree from an accredited university.
- Minimum five years of project management. Project management certification preferred.
- Minimum three years of grant management. Experience in application and management of competitive federal grants preferred.
- Biological or natural resources training preferred.
- Familiarity with anadromous fish, fish passage, and/or the Federal Columbia River Power System preferred.

#### Preferred Qualifications (in addition to above):

- Graduate Degree from an accredited university or relevant professional certification.
- Environmental resource ethic and value.
- Knowledge of biological environments in the Columbia Basin preferred.
